There are 5 doctors in the program that act as medical directors giving advice to the First Responders. First Responders provide basic life support which is a very important step in the chain of survival. This program started 9 years ago and provides protocols and documentation for calls and are an advocate for the agencies. They will cover training. There is also a \$3,000 grant for future upgraded training.
