All correspondence was read and taken care of.

The hospital accounts of Fred Vorroth and Henry Bogardo were brought to the attention of the Council. Both accounts were thoroughly discussed and the Council decided that neither account would be paid by the Council.

Complaints had been made about Mr. Mix hauling dead rats and dogs to the nuisance ground and not destroying them. It was decided that Mr. Mix be asked to bury any such animals that might be taken to the nuisance ground in the future.

Owing to the fact that so many cows were running at large and becoming a nuisance to the ratepayers, it was decided that the following owners be notified to keep their cattle out of their own lots:-

The fact that the culvert across 2nd Avenue at or near 5th Street, was not satisfactory, it was thought it advisable to see what could be done and as we had an offer from Fred Litz, which offer included a guarantee that the culvert could be raised satisfactorily, the offer was accepted for a price of \$25⁰⁰, including all grading, same to be applied on Litz' taxes, when the job was completed and approved by Council.

It was further authorized that a sidewalk be built on the North side of 7th Street and the East side of 1st Avenue, between 6th and 7th Street such sidewalk to be 3, 8" planks with a reasonable space between and properly supported, and further that if Mr. Litz failed to give satisfaction in the culvert, referred to in these minutes that a new culvert be put in along side the old one.

Councilor Schmaltz was asked to get prices on all necessary lumber and the work to be under his direction.

In the matter of auditors, Mr. Glen Weatherly was appointed for the year 1934, at a salary of \$10⁰⁰, and the Secretary was asked to notify the Department accordingly, for their approval.

The mill rate was set at 7 mills for Village Tax, on assessment of \$153,937⁰⁰, 5 mills, Calgary Power Co. on assessment of \$4700⁰⁰ and 4 $\frac{1}{2}$ mills for supplementary Revenue Tax, on land assessment of \$16,285⁰⁰.
