An agreement was signed and a deposit of \$25.00 on Lot 13, Block 9, Plan #1192FR to hold lot until February 15th, 1973 at which time they would either purchase the lot for \$950.00 including water & sewer installation or forfeit their deposit. Mayor Schmaltz also explained that a letter was received from the A.U.M.A. on the increase rates proposed by Calgary Power Ltd, also stating that at a meeting of the A.U.M.A. held in Edmonton on Dec. 13/1972 a resolution was passed that the Assocation appeal this increase to the Public Utilities Board, The Association would like to have the members of the A.U.M.A. give their financial support to this appeal. Councillor Hagel moved that the Village of Beiseker give their support to this appeal and would also give financial assistance if needed in the amount of \$1.00 per capita as suggested by the A.U.M.A. THAT exprand of the action taken by the mayor. The situation of dogs was discussed by Council and the Secretary was instructed to send copies of the Dog By-Law to all the owners of dogs, including a letter stating that the Village would like to have the co-operation of all the citizens that own dogs to obey all the rules and regulations stated in the By-Law.
