PURPOSE

The Public Meeting was called to give the residents of the Village an opportunity to review the concept design prepared for the park area of the Beacon Heights subdivision

CALL TO ORDER

The meeting was called to order at 7:40 P.M. by Mayor Richter

Mayor Richter introduced Mr. Bob Maniago of Calgary Regional Planning Commission and Mr. Ken Coutts of Calgary Parks and Recreation.

Mr Maniago commented on his concept design and showed slides of various play structures which could be located in the park. Several booklets of different types of play structures were available for review by the persons present.

General discussion and questions followed

Mr. Coutts commented that the most useful play unit was usually in the price range of \$5,000 to \$6,000. He also indicated that the most economical size of tree to buy would be a 1-inch calibre approximately 4 to 5 feet high. It was also suggested that a small berm be located around the playfield area and constructed so as to allow adequate drainage in the summer. When the drainage flow is obstructed in the winter time the playfield could then perhaps be flooded as a small skating area.

Mayor Richter thanked Mr. Coutts and Mr. Maniago for taking the time to visit our community and explain the design for the park.
