BUSINESS ARISING FROM MINUTES

(a) Arena Management Committee

Discussion was held concerning the outcome of the recent meeting with the Arena Management Committee held January 12, 1981. The \$3,000 allocation from the 1979 recreation budget has been paid to the Arena Management Committee and they have reciprocated with payment of their insurance invoice in the amount of \$3,523.28

(b) Industrial Park Lot Sales

No further reply has been received from Melton Real Estate regarding our new marketing arrangement. An interpretation was received from lawyer Carl Gurevitch and he felt that our interpretation of our marketing arrangement was reasonable. No further steps have been taken to resolve the problems with Alberta Housing Corporation. Mrs. Osterman has as yet been unable to arrange a meeting between Village representatives and the President of the Corporation.
