BUSINESS ARISING FROM MINUTES

(a) Public Works Items

1. The Hiring of the Foreman's Assistant

Councillor Fegan moved that Clifford Weegar be offered the position of public works assistant pending the receipt of acceptable references. If Mr. Weegar is unable to accept or if his references are not suitable then Mr. Dave Wright is the second choice. The new employee will be requested to start as close as possible to April 1, 1981. Carried.

(b) Beacon Heights Park Development

A rough estimate for the cost of completing the upgrading of the Beacon Heights Park was presented to Council.

Discussion was held concerning phasing of the project.

Councillor Courtman moved that the rough grading and the fence construction be carried out in the Spring of 1981 to a maximum cost of \$12,000 the funds for this project will be obtained from the Industrial Park recreation reserve.

Letters should be sent to residents who will require top soil for their lawn seeding this Spring requesting that they obtain their top soil from the loam pile prior to May 15, 1981. After that date top soil would have to be obtained from the old lagoon site.

(c) Beacon Heights Subdivision Phase II

The Municipal Administrator reported that Alberta Housing Corporation had not yet proceeded with preparation of the tentative plan of subdivision for submission to Calgary Regional Planning Commission. The Village of Beiseker is not in a position to proceed with this phase of the project since they are not owners of the land and therefore do not have the authority to submit the tentative plan. This problem will be discussed with the president of the Corporation at the Meeting scheduled for March 11, 1981.

(d) Homecoming 1981

Letters of invitation to Homecoming 1981 will be mailed March 11, 1981. Discussion was held concerning the possibility that the Village would supply logo pins to all those attending Homecoming.

Councillor Courtman moved that the Village of Beiseker allocate a budget of \$1,500 to the Homecoming 1981 project and that the first priority be the supply of logo pins.

(f) Recreation Grants

Mr. Sunada has not replied regarding status of the Master Plan Grant Application. Funds in the amount of \$883.00 have been received under the operational assistance program.

(g) Main Street Lane Closure

Quotations to carry out an appraisal on the main street lane property and the Marathon Property ranged from \$1,000 to \$1,400. It was decided that an appraisal would not be carried out. Mayor Richter moved that Public Tenders be called for the purchase of the 25' lane on main street, The reserve bid for this property would be \$400.00 per front foot - that is \$10,000 and the purchasor will be required to commence construction on the property within nine months and complete within 18 months.

Carried.

Further discussion was held concerning possible prices for the Marathon Subdivision property. Concern was expressed that making the price of this property too low would not encourage redevelopment of the main street properties. No decision regarding prices on the Marathon Subdivision was made by Council.

(i) Student Summer Program

Councillor Courtman outlined possible programs which should be carried out with Student Summer Program Funding for the summer of 1981.

Deputy Mayor Benoit moved that the Village of Beiseker submit applications for funding assistance through the Recreation Work Experience Program, the STEP program and the Summer Canada Student Employment Program.

Council will consider the appeal of the equalized assessment further once the dollar value of the school requisitions are known.

The Municipal Administrator commented on the recent visit to the Local Authorities Board to discuss possible borrowing by the Village of Beiseker during 1981.

The L.A.B. has indicated that no further approvals will be granted to the Village of Beiseker until the debt level has been reduced.

It was reported that the regional meeting to discuss the regional fire prevention conceptuall be held April 9, 1981 at 7:30 P.M. in Beiseker Memorial Hall

(o) Community School Concept

The workshop on the community school concept which was scheduled for March 14, 1981 has been cancelled. It was suggested that Mr. Ross Brayley of Parks and Recreation be contacted to prehaps organize a workshop to be held in Beiseker.

(p) Beiseker Memorial Hall

A letter has been received from the Beiseker Lions Club indicating that they would donate the old tables and chairs to the Village of Beiseker.

Councillor Courtman moved that the chairs and tables which are in good repair be kept and that those which were beyond repair could be sold.
