CALL TO ORDER

The meeting was called to order at 1:45 P.M. by Mayor Richter.

PURPOSE

The purpose of the Special Meeting was to discuss the Beacon Heights Subdivision Project with Mr. Keith Fawcett Project Manager, Alberta Housing Corporation.

- (1) Mr. Fawcett presented a copy of the residential land development agreement to Council
 - (2) The choice of an Engineering Consultant

Mr. Fawcett indicated that he had received a copy of the letter written by A.H.C. President Mr. K. Poholko to the Village of Beiseker.

This letter indicated "by the time this letter is received, you should have received approval from our Calgary office to use Mercon Engineering in Calgary to complete the engineering work required on the tentative plan. In addition, our Calgary office will be contacting them to indicate we are prepared to use them as our engineers on the condition that they will not undertake any work for the Village while under contract to the Corporation."

Mr. Fawcett indicated he interpreted this paragraph to mean that Mercon Engineering could not work for the Village on any other projects while employed by A.H.C. on the Beacon Heights Subdivision Project.

The Village on the other hand, interpreted this paragraph to mean that Mercon Engineering could represent A.H.C.on the Beacon Heights Project but could not represent the Village on the Beacon Heights Project only.

Discussion followed concerning the ramifications to Mercon Engineering Limited in the event that they were asked to proceed on behalf of A.H.C. The effect that this decision would have on the Village were also discussed. It was agreed that clarification should be received from Mr. Poholko as to his intent.

Councillor Courtman moved that in the event that Mercon Engineering could do no other work for the Village if employed by A.H.C. on the Beacon Heights Subdivision Project then the Village of Beiseker recommend to A.H.C. that Idec Engineering be awarded the Beacon Heights Subdivision Project. Carried.

Further discussion followed. If the clarification is received to the effect that Mercon could do other work for the Village but represent A.H.C. on the Beacon Heights Subdivison Project then Council would further consider the ramification of this decision.
