- 2. The previously approved outline plan of subdivision was not really flexible enough to allow other types of land use such as multi-family and single family residential.
- 3. A new concept plan was prepared to incorporate the various proposed land uses.
- 4. An option agreement had been drafted for negotiation with Mr. VanHee. Since any purchase or development on the part of the Village would ultimately be an Alberta Housing Corporation project, AHC was asked to comment on the Option Agreement prior to negotiation The written comments of AHC were not received until April 13 and their indications were not in favour of the proposed Option Agreement. Another format of Option Agreement was received from Alberta Housing Corporation and if Council chooses to pursue further negotiations with Mr. VanHee this format will be used.
 - 6. Council indicated to Mr. VanHee that a private developer had expressed some interest in developing his property.

 Mr. VanHee agreed to negotiate with any private developer who perhaps would be interested.
