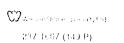

Mr. Miller presented Council with copies of the 1981 renovations and upgrading budget for the Beiseker School. The total budget amount was \$140,180.

(iii) Community School Concept

The proposed date for visiting other designated Community Schools would be early June.

(iv) Community Bus

Mr. Miller indicated to Council that financial problems were being experienced in the operation of two Community buses and perhaps some thought should be given to sale of one of the buses.

Deputy Mayor Benoit moved that the outstanding invoice from the Beiseker Community Bus in the amount \$524.00 for six months insurance be covered by the remainder of the 1980 Public Transportation Operating Assistance Grant and that a letter be written to the Golden Years Town and Country Club informing them of Council's decision and hoping that they concur with Council's decision. Carried.

(v) Beacon Heights Subdivision

> Any additional top soil required by residents of the Beacon Heights Subdivision may be obtained from the Old Lagoon Site. The residents will be responsible for their own transportation costs.

The approximate cost of paving the first phase of the Beacon Heights Subdivision was discussed.

Council recommended that since Mrs. Schissel's property has 2 proposed land uses i.e. residential & industrial it would perhaps be wise to proceed with a subdivision so that a developer who was interested in either residential or industrial development could purchase only that portion of property which they would require.

(b) Marigold Library System

Mayor Richter reported on the visit April 15, 1981 by Mr. Ian Bender, Consultant working on behalf of the Marigold Site Selection Committee.

Mr. Bender indicated that he would be making a recommendation to the Marigold Site Selection Committee by the end of April 1981

(c) Beacon Heights Playground

Various quotations for construction of a chainlink link fence around the Beacon Heights Playground were presented at the meeting. Prices ranged from \$8,111.76 from Beiseker Lumber (1979) Ltd. to \$8,867.00 from Anchor Fencing Limited. It was uncertain whether the quality of fence to be supplied by Beiseker Lumber was the same as the quotation from Anchor Fencing.

Councillor Carter moved that Beiseker Lumber be asked to clarify the type of fence construction. If Beiseker Lumber price for 9 gauge wire with heavier posts would be less than the Anchor Fencing quotation then Beiseker Lumber should be awarded the contract.

Carried.

(d) Marathon Subdivision

A report was given on recent conversations with Mr. A.R. Petrie, Assistant General Manager of Operations, Prairie Division of Marathon Realty Company Limited.

Mr. Petrie had located the Land Transfer in the C.P. Rail Office in Vancouver. The Transfer was awaiting signature by the Area General Manager and Vice-President Mr. Petrie was to advise the Village of any further

progress as soon as possible.

Council suggested that a call be made to our M.L.A. Mrs. Connie Osterman to see if she could make sure that Alberta Housing & Public Works would still be interested in purchasing the land even though there has been some undue delay in acquiring the property.

(e) <u>Beacon Heights Phase II</u>

Deputy Mayor Benoit moved that

- 3. That the tentative plan of subdivision which has been submitted to Calgary Regional Planning Commission represents Councils wishes with regard to lot sizes and lot layout.

(f) Rural Industrial Land Use

A letter which indicated Council's concerns regarding Rural Industrial Parks had been composed for submission to the Minister of Municipal Affairs. The content of the letter met with Councils approval.

(g) Lot Clean-up - Lots 36 & 37 Block 2 Plan 4011X

Mayor Richter moved that the notice to clean-up the property grant 30 days to complete the clean-up rather the 14 days referred to in the minutes of the last regular council meeting of April 13, 1981 Carried.

Deputy Mayor moved that a letter be written to Mr. Ken Ternowetsky indicating that his property should be for a single family residential use only and that his helper should not be living in his holiday trailer within the yard.
