NEW BUSINESS

Courtman: Councillor Courtman reported that the M.D. of Rocky View #44 would like to pass a Bylaw amending their contribution to recreation within the Municipal District. The M.D. does not want to pay 1 mill which would amount to \$19,000. They would like to pay the old levy of \$2,000.

Councillor:Courtman advised the M.D. that the Village will accept \$4,000 this year and will re-negotiate next year.


