The Council of the Village of Beiseker hereby resolves to petition the Local Authorities Board to have included into its boundaries all lands listed below and as shown on the attached map.

- All of the southeast quarter of Section Thirteen (13) Township Twenty-eight (28), Range Twenty-Six (26), West of the Fourth Meridian.
- 2. All of the southwest quarter of Section Thirteen (13) Township Twenty-eight (28), Range Twenty-six (26), West of the Fourth Meridian, excepting a) the west 462 feet of the southwest quarter of Legal Subdivision Four (4), and b) all of Registered Plan 1548 H.E. which are presently located within the boundaries of the Village of Beiseker.
- 3. All of the northeast quarter of Section Eleven (11) Township Twenty-eight (28), Range Twenty-Six (26) West of the Fourth Meridian, excepting that portion of Registered Plan R.Y. 226 which lies within said quarter section.
- 4. All of that portion of the south one-half of Section Twelve (12) Township Twenty-Eight (28), Range Twenty-Six (26), West of the Fourth Meridian that lies to the south and east of the Railway right-of-way as shown on Plan R.W. 31 and east of Road Plan 6389 GX.
- 5. All of that portion of the southeast quarter of Section Eleven (11), Township Twenty-Eight (28), Range Twenty-Six (26), West of the Fourth Meridian that lies to the south and east of the Railway rightof-way as shown on Plan R.W. 31.
- 6. That portion of Railway right-of-way as shown on Plan R.W. 31 that lies within the southeast quarter of Section Eleven (11) and the southwest quarter of Section Twelve (12), Township Twenty-Eight (28), Range Twenty-Six (26), West of the Fourth Meridian.

> Council had expressed concerns regarding Alberta Housing Corporation marketing policies to Mr. Keith Fawcett at the special meeting held October 2,1981. These concerns have been expressed in letter form and the draft copy of this letter was circulated to Council.

Council agreed that this letter conveyed the intent of their concerns.

An alternative means of obtaining clay fill for the subdivision development had been suggested by Mercon Engineering Limited. This alternative included the stripping of approximately 20 feet at the rear of Lots in the centre block of Phase II to a depth of approximately 4 feet. The clay removed during this stripping would be used throughout the subdivision and the lot would be restored to their original elevation with the excess top soil.

Council did not wish to proceed with this alternative because the future purchasors of these lots would be restricted in the area in which they could construct a garage or other accessory buildings.

Further discussion was held concerning the disposal of the extra grass which had accumulated on the Phase II area during the 1981 summer. These matters will be discussed further with Larry Isrealson of Mercon Engineering.
