### (1) <u>Sewage Lift Station</u>

Part of the unexpended debenture funds from watermain replacement project were to be used for upgrading of sewage lift station, in order to do this two pumps were installed, there are still some modifications to be done on the heating and ventilating.

After discussion it was decided that this modification should be tabled until March, 1982.

### (b) <u>Consideration of sewer repair billing</u> - A.W.Stadelman

Mr. Stadelman has received an invoice for sewer service repairs at his home on Seventh Street and First Avenue. The problems was definitely in the sewer service line. At approximately the same time however, the Village did have a problem with a main blockage at the intersection of Seventh Street and First Avenue. Since there is a possibility that his line may have become plugged during this temporary blockage, Mr. Stadelman feels that a 50% reduction in his invoice would be fair. The total amount being \$244.86.

- (c) Water Meters

Discussion was held concerning converting all water meters to remote read-out. 53% of the water meters in the Village have no remote read-out and 48% of the deposits are less than \$65.00. It would be a large expenditure to convert all the meters to remote read-out. 115 meters need to be converted at a cost of \$33.19 per meter which will be approximately \$3,800.

It was decided that 50% section will be converted at a time starting in 1982. Starting mainly with the homes where the occupants are not always at home.
