	(b) <u>Cargill Grain - Account 93D Lot 12 Block R Plan 1424JK</u>
	Cargill Grain has questioned the increase in value of the improvement assessment on this property.
	The situation had been reviewed by the assessor. The increase in improvement assessment was due to the fact that at the 1978 assessment, the house was only 40% complete and the 1979 assessment reflected that final construction was complete. The assessment is now comparable to similar structures within the Village.
