CALL TO ORDER

The meeting was called to order at 7:30 P.M. by Deputy Mayor Benoit.

DELEGATIONS

7:30 P.M. Diane Pomeroy, Calgary Regional Planning Commission

Ms. Pomeroy presented the results of the 1980 Census to Council. Highlights were:

- 1. The population of the Village of Beiseker as of June, 1980 was 508. This is a growth of 7.1% since the last census in 1979 (475 persons). This makes the Village's annual growth since 1974 3.5% per year.
- 2. The age distribution for Beiseker varies most significantly from the Alberta average in the 65 years of age or older category. The 11.4% of Beiseker's population that falls into this category is higher than provincial figure. It might be interesting to note that this figure is lower than the 12.6% of Beiseker's population which was 65 years of age or older in 1979.
- 3. The number of employable persons living and working in Beiseker is 116 or 35.0%. This is 62.0% of the employed persons (excludes the homemakers, the retired and the unemployed). Another 20.9% of the employed people in the Village travel into the City of Calgary. These percentages are certainly similar to those obtained in the 1979 census.
- 4. At the time of the sensus in 1980, there were 18 vacant homes in the Village and 1 under construction.
- 5. The occupancy rate for single family dwellings based on the number of people in such dwellings in Beiseker is 2.8.
- 6. Of the households which have lived in Beiseker for 5 years or less, 37.7% (43) have moved from the City of Calgary.

Mayor Richter arrived at the meeting at 7:55 P.M. and acted as Chairman for the remainder of the meeting.

(d) Airport Committee Report

Mr. Brownridge and Mr. Scott of the Aviation Branch of Alberta Transportation have reviewed local sites and will be negotiating the purchase of land in the Beiseker vicinity for the airport.

(e) Recreation

The Master Plan Grant application for the Arena is apparently being looked after. Councillor Courtman will investigate and report at the next meeting.

(f) East Central Summer Games Buttons

Deputy Mayor Benoit moved that \$25.00 be sent to the Recreation and Parks Department in Three Hills to cover the cost of East Central Alberta Summer Games Buttons and that the Village advise that we will be happy to participate in the future if advance notice is given. Carried.
