BUSINESS ARISING FROM MINUTES

(a) Review of Public Works Items

Dust proofing with oil was discussed and it was decided that one load of oil should be ordered to apply on first avenue and then fifth and the road past Beacon Heights Phase II.

Councillor Carter moved that one load of oil be ordered from Hub Oil to oil First and Fifth Avenues and the street past Beacon Heights, this should be applied possibly the first week of June.

There has been some sewer problems at the residence of Margaret Reding on Ninth Street. RotoRooter has investigated the problem and reports that the problem was in the street-this means that it is a Village responsibility.

Deputy Mayor Benoit moved that the damaged sewer line at the Reding residence be repaired from the street to the property line and that a representative of the Reding family be present when this is being done. Carried.

Frost boils in the lanes were discussed as there has been a problem in the lane between the Village Office and Beiseker Grocery Store. Public Works Department will be asked to use the front-end loader to repair this as soon as possible.

The placement of culvert and pit run at the road south of Beacon Heights was discussed. This will be carried out by September 1, 1982.

The public works department will be asked to carry out the Spring sewer flushing as soon as possible.

(b) Main Street Upgrading

A list of two alternatives for the possible use of the \$60,000 obtained from Alberta Transportation for Special Streets Assistance was previously circulated. These alternatives were discussed in detail.

It was decided that these funds should be used to carry out base preparation on first avenue, curb and gutter construction along first avenue (west side only) and base preparation on main street (90% of way from first avenue to second avenue - north side only) this would eliminate the need for immediate sewermain replacement. A letter will be written to Mr. Kathol to see if this will be satisfactory.
