(1) Rocky View Industrial Amendment

The Alberta Planning Board has ruled on Rocky View's Appeal to the refusal by the Calgary Regional Planning Commission to allow rural industrial parks as part of the 1971 Regional Plan.

The Alberta Planning Board has ruled in favour of Rocky View in that rural industry should be allowed within the Calgary Region. Rocky View has now filed another proposed amendment to the Alberta Planning Board decision. The implications of this proposed amendment were discussed. A Public Hearing to consider the proposal is scheduled for August 13, 1982. A brief presentation will be prepared for review by Council members at the regular meeting of August 9, 1982. At that time a decision will be made regarding the submission or the wish of Council to make the submission to the Public Hearing.

(2) Mrs. Sokolan also informed Council that the M.D. of Kneehill has now officially applied to leave Calgary Regional Planning Commission area and join Palliser Planning Commission their proposed effective date is January 1, 1983.

Mrs. Sokolan and Ms. Millet left the meeting at 7:45 P.M.

(a) Animal Control

Councillor Courtman and Mrs. Whitnack reported that Mr. Dave Gilberg had been approached regarding the provision of animal control services to the Village of Beiseker Due to other time committments Mr. Gilberg was not able to accept the position.

(b) Review of Public Works Items

Alfred Hagel, Public Works Foreman was in attendance for these discussions.

Mr. Hagel reported that:

- (1) The remainder of the oiling program has been completed for an approximate cost of \$2,060.00.
- (2) A water valve has been damaged near the residence at Block B Plan 4126HJ. The valve will be repaired on the morning of Tuesday July 27, 1982.
- (3) It appears that the water valve to Lot 11 Block 1 Plan 8110702 (Manyee Restaurant) may possibly be leaking. Mr. Larry Isrealson of Mercon Engineering Ltd. will be requested to review the matter to determine if the fault is with Richardson Bros. installation or if the valve was damaged during the tie-in by the restaurant contractor.
- (4) Mr. Hagel expressed concern about the extensive number of repairs required to the garden tractor and other small equipment.

Discussion was held concerning problems with the operation of this equipment.

Councillor Courtman will meet with the students and public works representatives July 27, 1982 to discuss the matter further.

Other Public Works items discussed by Council included:


