	Mrs. Sokolan, Mrs. Whitnack and Deputy Mayor Benoit reported to Council on the September 1, 1982 Local Authorities Board Hearing concerning the proposed annexation.			
	(4) The Recreation Master Plan Questionnaire			
	Councillor Courtman will again review the content of the proposed recreation questionnaire. Following this review the assistance of Calgary Regional Planning Commission staff will be requested in the final preparation and evaluation of the questionnaire.

- (d) A chunk of cement on the east side of second avenue between eighth and nineth street should be removed.
