- The eastside of first avenue between fifth (b) and sixth street requires more grading work.
- There is some handwork required along first avenue where the drainage was reset from main street to ninth street.
- The lane to the C.P.R. properties could use (d) more grader work. The time fram for this will depend upon the construction activity for the Alberta Liquor Control Board store.
- The swale at the back of the C.P.R. property (e) has been staked but the work has not been completed.

- (2) A representative of Alberta Environment should be invited to Council to discuss the possibility of obtaining additional funding for oversizing of the supply line and additional planning for Regional Utility System.

- (d) It is also noted that a requirement of the Well #7 licence was to provide static water level readings on wells at adjacent farms. Public Works should be requested to plan for a means to take these static water level readings.
- (e) Site Survey Block J Plan 4087FJ and Fourth Avenue

Mr. Regier indicated that Mr. Jack Starchuck would be willing to complete a certificate of survey for location of the apartment buildings and lift station on Block J Plan 4087FJ for approximately \$400.00 to \$600.00.

Father Charron was in attendance at the meeting to discuss problems with the subleasing of property to Alberta Housing Corporation. The improvements to the Senior Citizens Lodge have been exempted from taxes however since the property can not be legally described the assessor can not provide an exemption for the land which Alberta Housing Corporation leases. The Municipal Administrator is to investigate:

- (1) what would be required for subdivision i.e. description by meets and bounds or legal survey.
- (2) if any additional tax exemption can be granted to rectory since one of rooms is used for religious instruction.
