Councillor Stewart will pick up a pager for public works while she is attending the Calgary Regional Planning Commission meeting.

NEW BUSINESS

(a) Councillor Reports

Councillor Stewart and the Municipal Administrator met with the County of Wheatland secretary-treasurer, John Montgomery this morning. Mr. Montgomery inquired as to whether or not the Village of Beiseker would like to have their fire department provide fire services to approximately 30 families in the northeast corner of the County of Wheatland. If the Village of Beiseker agrees it would be set up on a membership system whereas each family would obtain a membership via a contract with the Village of Beiseker on a yearly basis. suggested that the membership fee be set at \$100.00. If the Village provides fire service to the area the Village will require a means to transfer water to the area for firefighting purposes.

One possibility would be to use the tanker at Lampson Canada at a set fee per use.

Deputy Mayor Beagle moved that the Village of Beiseker contract, on a Membership basis Fire Fighting services to the residents of the Northeast corner of the County of Wheatland at \$100.00 per year. Provided that the Village of Beiseker receive a notice in writing from the County of Wheatland confirming that the county wishes the Village of Beiseker to provide fire fighting services to these residents, and that a suitable arrangement for water supply to the area can be obtained. Carried.

Once contracts have been assembled they will be brought to Council for ratification and reviewed by a lawyer.
