## DELEGATION

(a) 7:35 P.M. John Berry, Lee Maher Engineering

Mr. Berry briefly went through the drawings and specifications of the proposed lift station.

The following points were highlighted:

- the building housing the current generator would have to be electronically and mechanically gutted.
- the pumps proposed in the specifications can handle a flow for a population of 1,000
- the size of the forcemain will determine the distance that sewage can be pumped.
- a new generator will be required as our current generator will not be able to start the proposed pumps.
- two pumps can be quoted on in the tender documents. This will allow for better pricing on the pumps.
- the specifications specify a fibreglass lift station. It is lighter, it would not corrode and they are currently made of good quality and are less costly to install
- the contractor must name all his suppliers

The Village of Beiseker wishes that local contractor Lampson Canada be invited to tender on the project and that local subcontractors, Bill Eitzen and Lorel Electric be recommended to the bidders as electrical contractors.

- (b) 8:00 P.M. Corporal Bodden, Beiseker R.C.M.P.
  - Corporal Bodden mentioned that he would be visiting Council from time to time to see if there are any concerns that Council may have with policing and to discuss items in general.
  - Pat Casey has taken the place of Darcy Rose on the Beiseker R.C.M.P. Detachment.
  - Beiseker R.C.M.P. Detachment will get another member probably in March if not sooner.
  - The Beiseker R.C.M.P. Detachment has Gloria Chissel now taking field training at the detachment.
  - The Beiseker R.C.M.P. Detachment is the seventh busiest detachment in the Province. Currently there is one staff member for 1,900 people whereas the Provincial average is 900 hundred people per staff member.
  - Several N.S.F. cheques have recently been written in the Beiseker area. This is hard to patrol unless all the business owners get together and compare notes to determine if certain individuals are writing several N.S.F. cheques at different locations.
  - Speed limits on North Road will be enforced more stringently in the near future. The R.C.M.P. will be giving a press release on this and the Village of Beiseker will print part of the release in the Village Informer.

### LATE ARRIVAL

Councillor Beagle arrived at 8:10 P.M.

- Village of Beiseker will review its noise Bylaw and obtain copies of Airdrie's and Wetaskiwin Bylaws. With the noise bylaw in place the R.C.M.P. would have better means of controlling house parties and other noise problems.
- The only way that the R.C.M.P. can deal with snowmobile nuisances is on a complaint basis. With no Bylaw in place on snowmobiles, snowmobiles are not allowed on any roads, lanes or streets in any community. The Village may look at putting in place a Bylaw which would allow individuals to use Village streets and roadways to get their machines to an appropriate location for operation.

#### FIREFIGHTING SERVICE CONTRACT

**BETWEEN:** 

#### VILLAGE OF BEISEKER

and

### (hereinafter referred to as the customer)

WHERE the customer wishes to receive firefighting services and the Village of Beiseker wishes to provide firefighting services to the customer subject to certain terms and conditions:

#### IT IS AGREED,

- 1) That the Village of Beiseker Fire Department will respond to fires on the customer's property when called by the customer provided that the Village of Beiseker Fire Department is not providing any of its services at any other place at that time.
- That the Village of Beiseker Fire Department will provide the following equipment and water supply when attending a fire:
  - (a) 1 pumper loaded with 500 gallons of water
  - (b) 1 First Aid response vehicle
- 3. The Fire Chief, or any other member in charge, at a fire is empowered to cause a building, structure or thing to be pulled down, demolished or otherwise removed if he deems it necessary to prevent the spread of fire to other buildings, structures or things.
- 4. The Fire Chief, or any other member in charge, at an incident is empowered to enter premises or property where the incident occurred and to cause any member, apparatus or equipment of the Fire Department to enter, as he deems necessary, in order to combat, control or deal with the incident.
- 5. The Fire Chief or a member of the Fire Department, acting in good faith and without malice for the customer in the discharge of his duties, shall not hereby render himself liable personally and he is hereby relieved from all personal liability for any damage that may accrue to persons or property as a result of any act required or by reason of any act or omission in the discharge of his duties.



- 6. That the customer agrees to indemnify and hold harmless the Village of Beiseker and the Beiseker Fire Department and its members from any damages to any property whatsoever and to any loss of life unless any of the above was caused by the gross negligence of the Village of Beiseker or the Beiseker Fire Department or its members.
- 7. That the customer in consideration of the services that will be provided as herein contained will pay a \$100.00 fee to the Village of Beiseker yearly by the 31st of January in each year.
- 8. The Village of Beiseker reserves the right to terminate this contract with the customer by providing written notice of the termination 30 days in advance and refunding the portion of fees for the balance of the contract period based on \$100 divided by the number of months remaining in the contract period.
- 9. The customer can terminate this contract by providing written notice of the termination 30 days in advance and forfeiting all fees paid.
- 10. Notice of the termination by either party shall be served in writing and shall be delivered personally or may be mailed by registered mail postage prepaid to the addresses as follows:
