(a) Review of Public Works Items

1. Campground Shower Coin Operates

It was mentioned that the clorinator is not functioning properly at this time, it is hoped that the new water upgrading project will be completed in the near future to alleviate this problem

4. Memorial Hall Water Problem

A water leak in the wall of the Memorial Hall must be capped off. It was determined that the curb valve is not functioning properly at the Memorial Hall and that sometime in the future it will have to be dug up and replaced.

(a) Review of Public Works Items (Continued)

5. Councillor Schmaltz will review the situation and if something needs to be done he will see that Public Works attends to the situation.

A letter will be sent to Miriam Klappe stating that the situation will be looked at.

It was also mentioned that when Public Works picks up garbage that they should make a conscious note of which places have garbage scattered about. When water meter readings are taken, a note may be left inside their door stating that if garbage is taken out on the day that garbage is to be picked up and not earlier, it would alleviate the problem of cats getting in and not spreading it around.

Deputy Mayor Klappe resumed participation at this time.

(b) C.N.R. Railway Crossing

Once again the Railway Crossing on Crescent Drive is in poor shape. A letter will be sent to the CNR asking that they upgrade this crossing in such a manner that the problems will not recur in the future. It was also mentioned that one load of the asphalt chips should be placed on the west side of the tracks to get rid of the pot holes that are adjacent to the west side of the railway tracks.

(c) Payment from Olds Concrete to Individual that watched their sidewalk while their cement set

This item will be looked into to determine if this individual was paid for her services from Olds Concrete.

(d) Economic Development Seminar in Fort McMurray

This item will be brought back to the next Council meeting

(e) C.R.I.B. Report

Councillor Stewart who attended a recent C.R.I.B. meeting handed out a sheet of paper which outlined why the 1990 requisition was set at \$14.70 per person. She mentioned that we were fortunate that we were only billed once as the agreement states that reguisitions are to be made four times a year.

Councillor Stewart also mentioned that none of the other communities that participated in C.R.I.B. have any complaints and that the City of Airdrie mentioned that if there are any questions or concerns that need to be answered they may be called at any time.

DELEGATION

(a) 7:45 P.M. Bill Maher, Lee Maher Engineering

Bill Maher went through his progress report on the Street Improvement program and mentioned that South Rock was very near completion of the street portion of the project. He also mentioned that when the geotechnical test bill and the hydrant bill were added to South Rock's bill the project is still under budget.

Bill Maher also mentioned that the concrete work by Olds Concrete is under budget thus far but they still have further work to do.

Councillor Beagle moved that payment of the account in the amount of \$38,032.74 to Olds Concrete be approved as recommended by the Engineer but that payment is not to be forwarded until they have satisfactorily completed their work.

Mayor Fegan moved payment of the account in the amount of \$120,373.34 to South Rock as recommended by the Engineer upon the Engineer's inspection of South Rock's completed deficiencies.

Bill Maher briefly went through the test results from Smith Dow and Associates and mentioned that there was nothing peculiar in the test results and that the test results turned out very good.

In regards to the Emerald Trenching bill, Bill Maher mentioned that Emerald Trenching was called out to another job and they came out to Beiseker in the middle of the afternoon to do a job that they thought would take three or four hours. Upon excavation it was determined that the situation was worse than originally thought and therefore the job took significantly longer. Because of this the workers went home and returned the following day thereby charging twice for mileage.

Bill Maher stated that our alternative would have been to ask contractors for bids which would have slowed down both South Rock and Olds Concrete for several days thereby this was the most feasible alternative.

Given the situation the following motion was made:

Councillor Stewart moved that the Emerald Trenching holdback of \$208.80 be paid.
