Mayor Fegan moved that a letter be sent to the Honourable Minister of Health Nancy Bethowski regarding our concern over the closure of the Irricana Health Unit and programs that may be eliminated. Carried.

been done and all that is left to do is to purchase curtains.

(h) Mutual Aid Agreement

The Administrator attended a Mutual Aid Meeting in Calgary and reported that the other parties to the agreement were not concerned with the costs of the responding party, as they believe that just having the response outweighs the concerns of the costs.

Because of this it was decided that the Mutual Aid Agreement be signed when presented for signing.

(i) Work Experience Employee

The Administrator mentioned that Coreen Knight has been working for the Village of Beiseker and will be for one semester as a work experience employee.

(j) <u>Taxpayer Arrangements for Outstanding Taxes Roll #1515</u>

This item was discussed and it was decided that the taxpayer could payoff the taxes in monthly installments by the end of 1991 if he gives a \$3,500 down payment either at the end of September or October and make payments of \$960.00 per month every month until the end of 1991.

This agreement is to be non-transferrable and no tax penalties are to be written off until the account is paid in full. If any of the postdated cheques bounce then that agreement is null and void.

(k) Organizational Meeting

The organizational meeting has been set for October 22, 1990 at 7:00 P.M.

(1) Tree Planting on Boulevard

Council decided that they will implement a tree planting program in the Spring of 1991 in which any homeowner wishing to plant one tree on the boulevard may do so with the Village planting an additional tree at no extra charge. This program will be advertised in the "Informer".
