- (a) Public Works Items
  - 1. Backflow Preventor

A backflow preventor should be installed at the International Mediwaste building, it will be determined to see if International Mediwaste will cost share the project.

2. Sewerline Repairs

Sewerline repair bills were received from Habbermel's as they required Carbon Plumbing & Heating to come out and do sewer repairs.

> The burnt out Christmas bulbs on the Village Office should be replaced in the near future. They should especially be in good repair on the date of the community Christmas Party which is December 12.


6. Shortage of Loam for Residential Developments

## 7:45 P.M. Hall Board

Mayor Fegan welcomed the hall board to the meeting. John Richter explained what was left to complete the construction of the building and the amount of money they have available to do it. He explained that Alberta Career, Development and Employment approved a grant to the hall board for labour in the amount of \$88,000.00. Of this \$88,000.00 a cheque was advanced to the hall board for \$44,000.00 which was to be used for labour. Because a general contractor was used, the wrong type of labour was employed thereby the hall board was only eligible for approximately \$25,000 of the grant and because of this the \$19,720.00 outstanding needs to be paid back to the Provincial Treasurer.

The Delegation went on to say that the Village received unexpected revenues from the sale of the old Memorial Hall and therefore request that the Village of Beiseker pay the outstanding balance for the Hall Board. It was also mentioned that the hall board set a standard when they started constructing the building and would definitely like to finish the building with that same standard and therefore the Village's constribution would go a long way in that regard.

David Wylie explained that he wished to receive a contract from the Village of Beiseker to do its snow removal and grass cutting.
