DELEGATIONS

Medi-Fire

Pat Dexter of Medi-Fire came to Council to explain the 911 cost. A.G.T. has put in an application to CRTC as of November to get approval for billing 911 services to it's telephone customers. It is expected that approval will be given around the end of December or the end of February and that it would be at least two months after that before they can start billing. The cost is expected to be between 42 and 44 cents with 7 cents of cost for being paid directly to AGT for collecting and dispersing the funds either to the Municipality or to the 911 call answer point.

Medi-Fire currently has an agreement with Irricana that after May 1 if AGT is not on stream with their 911 billing, the Village will be billed at 23 cents per phone line until such time as AGT billing is in place. The same would apply to the Village of Beiseker. Currently we are paying for 911 answering service for our fire only at 23 cents per capita. This will continue to go as the answering service and the 911 service are two separate issues. Pat Dexter also presented Council with a 911 plaque in recognition of the first 911 call in Beiseker. Pat Dexter also advised Council that they will need to have an updated list of things to do in case of emergency. He will draft a letter to Council stating what information he requires from the Fire Department, as well as Council. A meeting will be held with the Fire Department to get this information together for Medifire.
