Cellular Phone and Pager

Carmack Maintenance Public Works Foreman informed Council that it is hard for Carmack to give us an estimated cost for maintenance on the roads unless they have actually done the work. The next time we have a snow storm, Carmack will clear the snow and from that they will be able to tell us what the cost would be to do this maintenance work. The quote for paving is not in from South Rock yet, the paving quote from Carmack for the strip of road from highway #9 into the railway tracks range, between \$42,000.00 and \$45,000.00.

The furnaces at the Centennial Building and the campground will be inspected by Canadian Western Natural Gas and Public Works will report back to Council as to their condition.

Donovan Hagel Utility Trailer Public Works Foreman was instructed to look at the utility trailer and see what kind of a price could be established for it and report back to Council at the next meeting.

Sewer Snake

The Public Works Foreman advised Council that the sewer snake is missing. Council advised Administration to put a short advertisement in the Village Informer asking whoever borrowed the sewer snake from the Village to please return it.

Todd Ridd's Sewer Service

The bill for the temporary water service to Todd Ridd was discussed.

Sewer Backup Problems Earl Faulkner feels that there is a drop in his line as he keeps having a problem with sewer backup. Council advised that Public Works to monitor the situation through the winter and wait until spring to decide whether or not to camera the line.

Village of Acme

The Public Works Foreman advised that Public Works went to Acme to help repair a water main break. They were gone from 1PM - 2:30 PM.

Seminar in Banff

Public Works Foreman informed Council that he doesn't feel he should go to the Convention in Banff this year and wondered if the assistant should go in his place. Council decided that because of budget restrictions, we will leave the convention for this year and look at it again next year.
