# PUBLIC WORKS ITEMS Council Committee Report

Fire Hydrant

Mayor Taylor advised Council that the Fire Hydrant on 7<sup>th</sup> Street and 3<sup>rd</sup> Avenue needs replacing as it has become obsolete and parts can no longer be ordered for it. The approximate cost of replacing the hydrant is \$3,000.00.

It was the consensus of Council that this hydrant should be replaced.

Campground Upgrade

The wiring to power up eight sites has been quoted at \$1,500.00. Public works foreman to get an estimate on the trenching from Ken Ternowetsky. The current budget is \$2,000.00. It was suggested that the budget be increased to \$3,000.00 in order to provide the money necessary to get these sites powered up. Council agreed with this decision to increase the budget figure to \$3,000.00.

Site fees were discussed and the cost of the new sites will be firmed up later on this season as well as maybe increasing the cost for the non-powered sites. Administration to check with other campground on their rates.

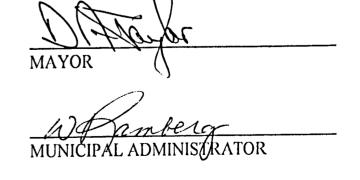
