CALL TO ORDER

Mayor Taylor called the meeting to order at 7:03 P.M.

ADOPTION OF AGENDA

Councilor Beagle moved to adopt the Agenda as presented.

Deputy Mayor Fegan moved to approve the minutes of the Regular Meeting of the Council of the Village of Beiseker held June 22, 1998 at 7:00 P.M. in Council Chambers.

PUBLIC WORKS ITEMS

Catch Basin - Beaver Place Cul-de Sac Water is still running into the road rather than running into the catch basin. The pipe in front of the catch basin on the north side is broken and should be replaced. The Public Works Foreman is to dig up the road and replace the broken pipe.

5th Street Hydrant

Now that the paving on 5th Street has been completed, the fire hydrant and stop sign on the corner of 5th Street and 2nd Avenue are now unprotected from someone running into them. The Foreman suggested that cement pillars be installed to protect the hydrant and sign and suggested that cement pillars should also be installed on the corner by Bill Turner's property. The Public Works Foreman also suggested that lines should be painted on the corner of 5th Street and 2nd Avenue on the Firehall side to stop cars from turning the corner too sharply. Council directed that the Public Works Foreman is to install whatever protection for the fire hydrant and stop sign that he deems appropriate.

Fence at shop

The fencing around the shop was completed. No fencing was installed on the southside to the creek nor along the railway side at this time.

Reservoir #2

On July 2, 1998 the Public Works Foreman discovered that the dry chamber in Reservoir #2 was flooded. The Foreman and Fire Chief Roland Brunelle worked all day to fix the problem and thought things were under control. The wells had to be closed in and turned on manually every 2 -3 hours. On Friday, July 3, 1998 the Reservoir was flooded again. It was discovered that a controller had shorted out. The Foreman and John Martens then spent all day Friday installing the new controller.

The Public Works Foreman requested that Fire Chief Roland Brunelle be paid at the rate of \$12.50/hour for the 8 hours of his time which he gave to work at the Reservoir and also to help on garbage pick up that day.

Reservoir #2 Res. #98-41 Deputy Mayor Fegan moved that Roland Brunelle be paid \$12.50/hour for 8 hours work.

Streets

7th, 8th & 9th Streets, 2nd, 3rd & parts of 4th Avenue were bladed on July 7, 1998. The Public Works Foreman was instructed by Council to tear up those same streets and reoil commencing July 20, 1998 as well as to fill the pot holes on Crescent Drive near the railway tracks. Administration is to send a letter to the M.D. of Rockyview No. 44 about fixing the pot holes on 1st Avenue going to highway #9.
