# (b) Administrator's Report

1. Our need to order coffee as much as we have in the past has dwindled dramatically. If we don't order next time our machine will be taken back. Would like Council's permission to purchase a smaller coffee maker from Home Hardware or Costco with a permanent filter and also a Carafe to use when we need a steady supply of coffee made.

Cou. Beagle moved to purchase a coffee maker, permanent filter, carafe and electric tea kettle from Home Hardware.

- 3. 911 Got a call from the City of Airdrie regarding the 911 issue. They are waiting to see what the City of Calgary are doing before they proceed with their pilot plan.
- 4. Marigold Library received a letter back from the Marigold Library System. They are unwilling to lower their prices any further.
- 5. Attended the Regional Manager's Meeting today at which there was much discussion regarding assessments, planning and the changes in the safety codes act. Council needs to make a decision in the near future as to which way they want to go in each of these three areas. The Administrator is still getting information and having delegations come to her office to discuss planning and assessment. She should have enough information together soon to advise Council as to what options they have.
- 6. We have Council storage boxes in the office for any incoming letters, etc. for individual council members. Please check periodically for new information.
- 7. The Administrator is getting a quote to recover the six chairs. This information will be available at the next council meeting.
- 8. The Administrator reported that 83.66% of the taxes have been collected. If we looked at the percentage of current taxes not taking into consideration arrears, 91.83% of current taxes are paid.

## (c) Other

- 1. We need to fill a vacancy for an M.P.C. member. The Administrator will put this in the Village Informer for volunteers.
- 2. <u>Squirt Logo</u> Brian Isert would like permission to use the "Squirt" logo on his business cards. Council didn't have a problem with this.
- 3. <u>Cargill Letter</u> A Draft letter was presented to Council. This letter was to Cargill to see if our area would be suitable for their Canola processing and refinery plants. Council approved the letter. The Administrator will fax the letter and then send a hard copy with additional tourist information in the mail.
