Vera Schmaltz, Golden Years Senior's Club Vera Schmaltz advised Council that the Golden Years Senior's Club would like to recommend to Council that the Village of Beiseker should start making plans for Alberta's 2005 Centennial. She suggested to contact all of the organizations in the community and to have them nominate one representative from each together with a Council representative to sit on an organizing committee. Council thanked Mrs. Schmaltz for bringing the matter to Council's attention.

Randy Hellier & Sandy Wilson, Alberta 2005
Centennial Railway Museum Society

Randy Hellier provided Council with a photograph of the style of gate that Alberta Trailnet is requesting to be erected at both the north and south ends of the CPR right-of-way. There are four (4) gates to be installed, one on the north side and one on the south side of Highway #72, and one on the north side and one on the south side of Beacon Heights Road by the Public Works Shop. Each gate will have a "no motorized traffic" sign. Gates are being acquired from UFA and Alberta Trailnet is covering the cost of the gates. The gates are to be installed within the next two weeks. Council advised Mr. Hellier and Ms. Wilson that they had no objections regarding these gates provided that they meet the required setbacks from Highway #72.

Mr. Hellier advised Council that the date for the spike laying ceremony originally scheduled for August 22, 2004 will have to be set back to sometime in September, the date as yet to be determined.

Kneehill Regional Water Services Commission

Mayor Fegan advised Council that the KRWSC has let out tenders for the reservoir building and the pipeline from Drumheller to Carbon to Acme. Out of the valley the pipeline will be constructed of steel and duct tile iron to Acme. Beyond that, the pipeline will be PVC. Overall at this point in time the project is \$800,000 over budget. The commission is looking into additional funding on a 75/25 basis from the Province. The majority of the environmental approvals are now in place. The commission is in the process of negotiating with Kneehill County for 28 road crossings. It is expected that that construction on the reservoir contract will commence on July 5th and July 16th for the first section of the pipeline construction.

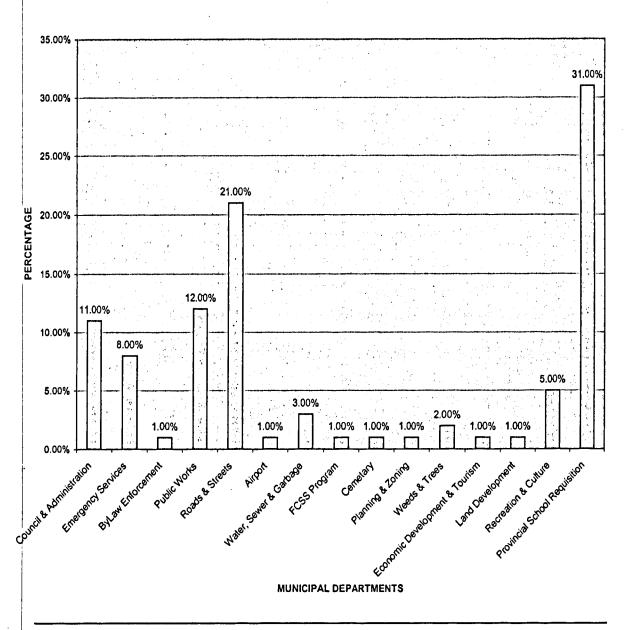
